THE REFERENDUM IN BRIEF...

A MORE EQITABLE FE	EE
STRUCTURE:	

This year the Student Council is recommending a restructuring of the Student Union Fees. Since 1979/80 there has been a wide variation in the amount of money each student pays for the operation of their Union. For example, this year if you were a student taking three (3) credits you payed \$ 6.00 into the Union, but if you happened to be taking three and one half (3

1/2) you would pay \$100.00. This hardly seems fair.
Each year the Student Council ends up trying to stretch the finances over the entire student body and serve all needs, however, because of the existing fee structure it is impossible.

The proposed new fee structure pro rates the Student Union Fee on a per credit bases thus ensuring that all student are treated fairly and equally.

MOUNT SAINT VINCENT STUDENT UNION

(PROPOSED)

CONSTITUTION

This document shall be the constitution of the Mount Saint Vincent University Student Union and shall take precedence over any and all by-laws, rules, regulations and policies enacted by the Mount Saint Vincent Student Union.

ARTICLE I THE PREAMBLE

- 1.1 The organization shall be known as the Mount Saint Vincent University Student Union, hereinafter referred to as the Union.
- 1.2 The Union shall act as the sole representative of the entire student body attending Mount Saint Vincent University, which is located in the City of Halifax, Nova Scotia, Canada.
- 1.3 The aims of the Union are:
- a. to serve the needs of students.
- b. to represent the students of the Mount Saint Vincent University to the University Adminstration, to the public, to public officials, to other centres of learning and to other organizations.
- c. to advance the cause of higher learning at Mount Saint Vincent University, in the province of Nova Scotia and the country of Canada.

VOTE YES

- d. to promote and assist in maintaining an academic and social environment free from prejudice, exploitation, or abuse on the basis of, but not limited to, sex ,race, language, religion, age national or social status, political affiliation or belief, sexual orientation or marital status.
- e. to work in joint effort with Mount Saint Vincent University to ensure that the policies and goals of both organizations are mutually respected.

ARTICLE II MEMBERSHIP

- 2.1 A student shall be any person who registers at Mount Saint Vincent University in any credit course.
- 2.2 A member of the Union shall be any student who pays the Student Union Fee.
- 2.3 The term of membership shall begin or be renewed on the date of the payment of the Student Union Fee.
- 2.4 The term of membership shall end on the first September thirtieth (30) following the date of payment of the Student Union Fee such that at least six (6) months of the term of membership have elapsed.
- 2.5 Every member of the Union shall be entitled to vote in any election or referendum held by the Union, subject to any restrictions in this constitution and subject to any by-laws governing elections and referenda.

2.6 Such friends of the Union may be admitted as members of the

Union and shall be considered as Honorary. Members of the

Mount Saint Vincent University Student Union. Honorary Members of the Union may not vote in any election,

referendum or any other issue which may be subject to a vote within the Union. Also, Honorary Members of the Union may not stand for election to the Students Council or any other organization under the Union. The duration of e a c h H o n o r a r y Membership and any associated privileges shall be at the discretion of the Student Council.

Article III Student Council

A) AUTHORITY

- 3.1 The Union shall be officially governed by the Student Council, which shall be comprised of the students of the Union.
- 3.2 The Student Council shall be responsible to the students of the Union for any matter delegated to it by the Union.
- 3.3 The Student Council shall be vested with the legislation authority of the Union.
- 3.4 The term "Council" may be used to refer to the Student Council and the term "Councillor" may be used to refer to a member of the Student Council.

B) COMPOSITION AND TERMS OF OFFICE

- 3.5 The composition of the Student Council shall be as follows:
- a. President
- b. Executive Vice-President
- c. Internal Vice-President
- d. External Vice-President
- e. Academic Vice-President
- f. Treasurer g. Speaker
- h. Board of Governor Representative (two) elected by the student body
- i. Full Time Senate
 Representative (two)
 elected by Fulltime Students.
- j. Part-Time Students'
 Senate Representative
 elected by Part-Time
 Students.
- k. Non-Traditional
 Student Representative
 elected by the members
 of the Mount Association
 of Non-Traditional
 Students Association.
- I. Off-Campus
 Representative elected
 by non-residence
 students.
- m. Residence Representative elected by residence students.
- n. Graduate Student Representative elected by the members of the Graduate Students Association.
- o. Cooperative
 Education
 Representative elected
 by the Cooperative
 Education Society.
- p. International Student Representative elected by the International students
- q. Representatives elected by the students of each Academic Faculty Division.

- r. Tourism and Hospitality Management Representative elected by the Tourism and Hospitality Management Society.
- 3.6 All members of the Student Council, excluding the Speaker, are entitled to have one vote.
- 3.7 The Term of office for all members of the Student Council shall begin on May 1 following the General Election and end on the following April 30.
- 3.8 The following Student Councillors shall be elected by and from the membership of the Union:
- a. President
- b. All Vice-Presidents
- c. Board of Governors
- 3.9 The following Student Councillors are appointed members of the Student Council:
- a. Treasurer
- b. Speaker
- 3.9a Student Council reserves the right to appoint the following positions if the respective constituent have not elected the position by November 1:
- a. Cooperative Education Representative
- b. Graduate Student Representative
- c. Tourism and Hospitality M a n a g e m e n t Representative
- d. Non-Traditional Student Representative

- 3.10 No member of the Union shall stand for member who, as per election for more than one council seat or stand for election to a council seat in a byelection while holding another Council seat, nor hold more than one seat on council.
- 3.11 All members of Student Council are required to perform the following:

a. keep informed on all events affecting members of the Union.

b. act as a liaison between Student Council and their individual constituency.

c. represent the concerns and views of their constituency to Student Council.

d. carry out all duties as per the councillors terms of reference and any other duties which council may from time to time assign.

e. put their name forth to sit on at least one standing committee of Student Council.

- f. attend all meeting of Student Council. councillor may not miss three consecutive council meetings or five in total without approval from the President of the Union.
- 3.12 When a councillor has failed to fulfil their duties as per Article III section 3.11 or if the individual has committed gross dereliction of duties, their position may be declared vacant and the individual removed from office providing that at least one of the following has been conducted:

a. Student Council is presented with a document bearing the bonafide signatures of fifty percent plus one of the constituents of the individual council member.

or

b. a two thirds (2/3) majority vote of Students Council

- 3.13 Any council Article III section 3.12, moves to remove a elected councillor from office must give notice of their intentions either by way of written notice to the individual concerned and to the Speaker of Council or at council meeting. In each case notice must given at least one week prior to the official vote of removal from office.
- 3.14 All resignations of officers of the Union, members of the Council, or any Council appointees shall be submitted in writing, to the President of the Union, to be submitted at the next regular Council meeting for action thereon.
- 3.15 Should a vacancy occur in the office of the President or any of the four (4) Vice-Presidents before November 1, an election for this position shall be held within one month. In the case of a vacancy by the President, the Executive Vice-President shall assume the duties of the President for the interim.
- 3.16 Should a vacancy occur in any of the four (4) Vice-Presidents on or after November 1, council shall appoint a Vice-President. All members of the Union shall be eligible for appointment.
- 3.17 Should a vacancy occur in the office of the President on or after November 1, Council may, if time permits, hold an election within one month of the vacancy. However, if Council deems that time constraints do not permit for an election to be held given the nature of the position then, in such a case, the Executive Vice-President shall assume all duties of the position of President for the remainder of the term of office.

3.18 Should a vacancy occur in any elected position, other than that of President or Vice-Presidents, an election may be held for the vacant position. Council reserves the right to appoint a member of the Union through the appointment Committee to the vacant position if time constraints do not permit an election. These appointment carry all the rights and privileges associated with the position.

C) **MEETINGS**

- 3.19 There shall be a regular, open meeting of Student Council twice every month during the University term, with allowance made for the Christmas and Spring Break.
- 3.20 The Speaker of Council shall be responsible for providing notice of Council Meetings to all councillors and to the members of the Union.
- 3.21 A meeting of Council can be Called by the Following:
- a. the President of the Union
- b. a simple majority of the executive in an executive meeting.
- c. a petition signed by no less than one fifth of the members of council
- 3.22 A councillor may appoint a member of the Union to be a proxy during the councillor's absence from a council meeting. The proxy:

a. must be a member of the Union who is not a councillor.

b. must be from the same constituency.

constituency.

d. shall have the privileges and responsibilities of a councillor, and

e. shall not be bound by the councillor's instructions.

- Quorum for a 3.23 meeting of council shall consist of fifty percent (50%) plus one of the total current voting member of Council, including proxies.
- 3.24 All motions put before a meeting of the Union or the Council shall be decided by a majority vote, fifty percent plus one, with the exceptions of those specified in the union's

constitution.

- 3.25 All meeting of the Union shall be subject to the terms of this constitution, rules, regulation, policies and by-laws of the Union. Where no guidelines exist within the Union then the meeting of the Union shall be conducted in accordance with the rules of parliamentary procedure set out in the most recent edition of robert's rules of order.
- 3.26 Council meetings shall be open to all members of the Union and invited guests, unless closed to discuss staff related matters or by a two thirds majority vote of those voting members present at a meeting.
- 3.27 A motion must be sponsored by any two members of the Union provided that at least of them is a Councillor or a proxy.
- 3.28 Any member of the Union or any guest with the permission of Council may speak at a council meeting.
- 3.29 Only councillors or their proxies may vote at a council meeting.
- c. shall act on behalf of of 3.30 Should a conflict of represent the interest arise, the affected councillor or proxy shall declare that a conflict of interest exists and abstain from voting on the question.
 - 3.31 No person shall hold more than one vote at a council meeting.

ELECTIONS D

- 3.32 A General Election shall be held in the month of March each year on any two consecutive official class days to fill the seats of:
- a. President
- b. Executive Vice President
- c. Internal Vice-President d. External Vice-President
- e. Academic Vice-President
- f. Board of Governors Representatives(2)
- g. Senate Representative (2 FullTime and 1 Part Time)
- Residence h. Representative
- i. Off Campus Representative
- i. Representative of Academic Faculty Divisions
- k. International Student Representative.
- 3.33 The following positions shall be elected during the time in which the respective chartered organizations conduct their individual elections: a. Non-Traditional
- Student Representative b. Cooperative Education Representative
- c. Tourism and Hospitality Management Representative
- d. Graduate Student Representative.
- 3.34 A by-election shall occur during the month of October on any two consecutive official days classes to elect any position not filled during the General Elections. 3.35 The dates for the General election shall be approved by council on
- or before January 31, and the dates for the byelection shall be approved by the student council on or before September 21.

CHILDCARE:

CAN 'WE' AFFORD IT ?

How I Spent My Long Weekend . . .

After going through several hundred needs surveys over the Thanksgiving weekend and dealing with hundreds of statistics I decided I should respond to some of the questions and comments that were raised.

It seems that a lot of students don't realize the difficulties encountered in finding quality and most importantly AFFORDABLE child care. There are approximately 154 child care spaces avalible in the Halifax-Dartmouth area for infants aged 3 months - 18 months. . . not a lot is it? For the older child (18 months -

5 years) the picture is a little brighter, but the waiting list can be anywhere from 14 months to 2 years, and if you need a subsidized postion it is even worse. One M.S.V.U. student registered her child at child cares throughout the area when she was 5 months pregnant - her son is now thirteen months old with no sign of an affordable licensed child care in sight until next year! So what does she do. . . She uses S.P.A.C.C. (Student Parents Allied For Child Care). If you don't know what that is it is a temporary babysitting service set up for students by

students in SAC 442, drop in some time.

As for the child study center on campus you ask why students do not use it? The cost is the number one reason. . . Most child care facilities charge on average (without Government subsidy) is approximately 70 to 75 dollars per week. . . The child study center, however, is one of the most expensive in the area and charges the exoberant fee of 91 dollars per week!! Now do you wonder why students don't use it? How many students do you know that can afford

As for being able to claim child care expenses on your student aid forms. . .sorry! If you look closely you will also see that no verification is required - what does this mean? This means that you can claim all the child care expenses you want but they don't reimburse you for it - for example: put yourselfin this position - you are married or a single parent who just happens to be a student also, you have the additional exdpense of child care which can range from \$300.-\$3,000. per year. You will recieve the same amount of loan and bursary that a single student living at home does... does this seem fair to you?

I was pleased with the response I recieved from the Mount students who participated in the survey and welcomed the comments. suggestions, recommendations and questions given me. You will no doubt be hearing from me in future articles in the Picaro as I am not about to give up on the idea of an affordable child care facility on this campus.

b. no later than seven (7) days prior to the date on which council is to consider the question, a notice of consideration of the proposed referendum and date and time of the meeting shall be displayed in prominent places of the campus.

c. the referendum is supported by a two thirds majority vote in a council meeting.

d. notice of the referendum question, which received a two thirds majority vote of council, is given twenty eight (28) days prior to the date of the referendum vote.

- 1.5 Within twenty-four (24) hours of the close of the polls the chief returning officer shall prepare and post in prominent places on campus the official list of results as well the official results shall be published in the following edition of the Union newspaper (Picaro or otherwise)
- 1.6 Referenda shall be conducted by the Elections Committee following the regulations set out in the constitution and Student Council regulations. The Committee can make such rules pursuant to those regulations as it deems necessary to ensure the effective adminstration and good conduct of such referenda.
- 1.7 Any member of the Union may request a recount of the votes cast by filing a written request with the chief Returning Officer within forty-eight (48) hours of the posting of the official list of results. Such a recount shall be made

ARTICLE VIII BY-LAWS

- 1.1 The Student Council shall have power to enact by-laws
- 1.2 By-Laws shall take precedence over any and all rules, regulation, or policies enacted by the Union except for those provisions of the constitution.
- 1.3 A by-law may be enacted at any meeting of Student Council a two thirds (2/3) majority of those present and voting provided that proper notice and public notice has been given.
- 1.4 Proper Notice shall be the reading of the proposed by-law without debate at a meeting of Student Council no less than fourteen (14) days prior to the meeting at which the proposed bylaw will be considered.
- 1.5 Public Notice shall be the prominent display of the proposed by-law and the time date and place of the council meeting at which the Bylaw is to be considered at least seven (7) days prior to the meeting which the proposed by-law is to be considered.
- 1.6 A by-law shall be in effect immediately upon enactment by the Student Council.
- 1.7 Amendments to bylaws shall be enacted in the same manner as bylaws are enacted.

ARTICLE IX POLICY

- 1.1 Student Council shall have the authority to enact policies.
- 1.2 Policies shall not conflict with or attempt to vary any provision of the constitution, or any provision of any by-law of the Union.
- Policy shall be defined as direction given to the executive council member appointed position or staff of the Union which instructs the individual(s) concerned to conduct the business of the Union and /or as to what public attitude will be adopted by the individual(s) concerned on any matter that Student Council may deem appropriate.
- 1.4 A motion of policy shall be moved and seconded by a voting member of Student Council or their proxy and requires a simple majority of those voting members present.
- 1.5 A policy shall be in effect immediately upon enactment by Student Council.

ARTICLE X **FINANCES**

- The University 1.1 Adminstration is authorized to collect the Student Union's Fee from every student each year at the time which the payment of the University Fee is made.
- 1.2 The Union may collect monies through business enterprises and

other means as approved by the Student Council.

- 1.3 All monies collected by the Union shall be deposited in the Union's name in a financial institution approved by the Student Council
- 1.4 The Treasurer shall be responsible for the presentation to the Student Council of a budget detailing the appropriation of the Union's monies, no later than July 30.
- 1.5 The budget shall be subject to ratification by the Student Council.
- 1.6 Student Council may amend the budget at any
- 1.7 The Treasure shall be responsible for the disbursement of the Union's monies in accordance with the budget ratified by Student Council
- 1.8 The Treasure shall be responsible to the Student Council for the presentation of quarterly financial statements and other such financial statements as may be requested by Student Council.
- 1.9 The President of the Union and the Treasure of the Union shall be the official co-signers of all Union finances.
- Student Council 1.10 shall, within one month of taking office appoint a competent auditor to conduct an examination of the books for the preceding financial year and to prepare a report

for the Student Council and the membership of the Union finances

ARTICLE XI DISSOLUTION

1.1 In the event that the Student Council is dissolved, all monies and possessions shall be held in trust by the University until such time as another Student Council is activated.

ARTICLE XI INTERPRETATION

1.1 In this Constitution, the definition of any word shall be that contained in Webster's Ninth New Collegiate Dictionary (1983) Edition, excepted as The MOUNT SAINT VINCENT UNIVERSITY STUDENT UNION CONSTITUTION MARCH 1989.

- 3.36 The Student Council shall from time to time make regulations regarding the adminstration of the elections under its jurisdiction, and the elections committee shall make such rulings pursuant to those regulation as it deems necessary to ensure the effective adminstration and good conduct of such elections.
- 3.37 All candidates shall run on separate ballots but may campaign as a slate.
- 3.38 The candidate receiving the highest number of vote cast shall be deemed elected for that position.
- 3.39 No candidate shall win by acclamation; in the event there is only one candidate, the number of ves votes must exceed the number of no votes.
- 3.40 In the event of a tie between the candidates or a tie of the number of yes and no votes a revote will be held within two official days of classes. In this ballot the campaigning shall remain closed an in the case of a tie between individuals, only those tied for first place shall have their names on the ballot.
- 3.41 Within twenty-four (24) hours of the close of voting in any election, the chief Returning officer shall prepare and post in prominent places on campus the official list of results as well the official results shall be published in the following edition of the Union newspaper (Picaro or otherwise)
- 3.42 Any Candidate may request a recount of thew votes cast by filling a written request with the Chief returning officer within forty eight (48) hours of the posting of the official results. Such a recount shall be made within twenty-four hours of the receipt of the written request.

E SUMMER COUNCIL

- 3.43 Summer Council shall be the term used to describe the operation of council during May 1 until the first official day of classes in the month of September.
- 3.44 Quorum for Summer Council shall be five (5) voting members of Council and at least one meeting shall be held each month.
- 3.45 The President and **Executive Vice President** shall receive a salary during the term of Summer Council and shall report in written form to council of their activities during Summer Council by no later than September 30.

ARTICLE IV EXECUTIVE

- 1.1 The adminstration of the Union shall be vested in the Executive

- 1.4 The Executive shall be responsible for the following duties and receive an honorarium for the performance of those duties:
- a. Meet prior to each Council Meeting

 - k. Orientation c. use the facilities of Chairperson
 - I. Senior Class President m. any other position deemed necessary by the Student Council

VOTE

- The application 1.2 period for appointed positions shall be open for at least 21 days and shall close after the date of the Unions elections.
- All appointed positions shall be subject to perform the duties listed in their individual terms of reference and any other duties as from time to time designated by student council.

STANDING COMMITTEES

- 1.4 The following shall be standing committees of the Student Council and shall be ratified by council and shall report to council as required or requested to by council:
- a. Application Committee
- b. Elections Committee
- c. Finance Committee
- d. Pub Management Committee
- e. Constitution and Policy Committee
- f. Honoraria Disciplines Committee
- 1.5 All Standing Committees shall perform the duties as per the Committee's terms of reference and perform any other duties which council may from time to time designate to the Committee.

ARTICLE VI CHARTERED **ORGANIZATIONS**

- 1.1 No student organization, society, club, association or the like, in the name of the Union, shall without authorization of the Union:
- a. operate on campus b. solicit for fund, membership, or clientele from among members of Winter Carnival the Union or any part thereof.
 - thew Union for their operation.
 - 1.2 Student Council may grant a charter to any organization, society, club, association or the like which makes application for a charter, may revoke

- suspend the operation of such a charter by a two third 2/3 majority vote of council.
- 1.3 The Internal Vice President and the Treasure of the Union shall have the right to examine the records. reports and minutes of any organization or the like, which has been chartered or makes application to be chartered under the student Council.

ARTICLE VII REFERENDA

- 1.1 The Student Council is required to hold a referendum to:
- a. affiliate with or withdraw from an external organization
- b. matters related to the increase or decrease of student Union Fees.
- c. to amend the constitution
- d. in matters involving major policy decisions the Student Council considers that necessitate consultation with the members of the Union
- 1.2 The referendum shall be binding on council providing that a simple majority of those voting in the referendum vote in favour of the question posed and that those voting constitute at least ten per cent (10%) of the membership of the Union, except for a constitutional referendum whereby two thirds of the union membership vote in favour of the amendment and where those voting constitute at least ten per cent (10%) of the membership of the Union.
- 1.3 All members of the Union are eligible to vote in any referendum.
- 1.4 Proper notice must be given to all referendum questions and proper notice shall be deemed given when:






