Agnes O'Donnell Kelly

Agnes (O'Donnell) Kelly, Class of 1939, died the first week of the new year and many are poorer for the loss. especially her daughters Mary and Anne and her sons Michael, Kevin, James and Pat. Her Mount alumnae friends who go back 40 years - and those she travelled with to New York and London - mourn her too.

Agnes, who participated fully in the university's 60th anniversary festivities this Fall, was enthusiastic in her support of the Mount's alumnae association

She usually tackled the "plant table" at the annual fall fairs and could charm contributions out of all her friends and any others with whom she came in contact. And she did it with such good humor.

At meetings, she usually sat in the back row but could command the floor with the best of them on a point needing clarification or dear to her heart. According to Agnes, there was always a proper and fair way of doing things. Agnes was taught and taught well

Apart from her commitment to the Mount and her work with the alumnae. Agnes was dedicated to the Beaverbank-Sackville community in which she had lived most of her life. After her marriage to Lieutenant Commander Michael Kelly, RCN, she travelled to various postings but returned home to Beaverbank where her children were raised.

Many tributes have been made to Agnes since her death, by friends and colleagues such as Halifax County School Board commissioner Shirley McGovern who said: "I know whenever we had church suppers at St. John Vianney's, Agnes and the crew from Beaverbank were a Godsend when it came to cleaning up." Marion Allen of the Sackville Historic Society said she had known Agnes all her life and that she would miss her greatly. "She was always full of energy when it came to getting things started and finished. Even after she was widowed, she was never the type of person to feel sorry for herself. She was one of the kindest people I have ever met. always thinking of other people, especially the elderly." And, according to Allen. Agnes would "open her house to everyone, even people she had just met."

Agnes will also be remembered for the contribution she made to the Beaverbank schools, where she worked as secretary to the Sackville School Board and did substitute teaching. "She was so liked by the students. teachers and the parents ... a very special person ... she mothered us all and I'm going to miss her a lot," said Sycamore Lane School principal Anne MacAusland.

Tributes have also come in the way of donations to the Agnes O'Donnell Kelly Memorial Fund for scholarship purposes. Already an estimated \$2,000 has been received. Those who would like to contribute should contact the alumnae office. As Agnes would say, "It makes sense."

### Mount Alumnae Featured **On Special TV Programs**

Everyone's a star on the Alumnae Special — the new television show that goes on the Atlantic Satellite Network twice weekly via the Mount's DUET program (Distance University Education via Television).

The first 13 week series began during the Fall semester when the Mount's alumnae officer, Dilly MacFarlane, approached DUET with the idea of using the time available to promote alumnae activities. The previous year had seen the university's public relations office use the same time slot to promote Mount activities and its faculty and students. "There is such a wealth of

interesting alumnae in the metro area," she says, "that I thought we should conduct a series of interviews with them. It's one more way to reach out to the community and let them know what's happening at the Mount and it's also a great way to strengthen our alumnae network.'

Because the program goes out to many centres in the Maritimes, and also to parts of Quebec, Southern Ontario, Maine, New Hampshire and Vermont, it reaches alumnae who now live far away from the Mount and helps them to keep in touch with their alma mater.

MacFarlane, who hosts the Alumnae Special, says she loves every minute of it. "I look forward to the taping sessions. It's exciting, and the people I interview give me new enthusiasm. My guests bring their own energy to the program and as I know many of them personally, the interviewing is very easy and spontaneous.

MacFarlane usually sits with her guests for five or 10 minutes before taping begins, to put them at their ease and make them feel comfortable. This friendly and informal approach seems to pay off because, MacFarlane says, "Everyone feels that the interviews are fun '

As far as she knows, the Mount is the only university in the country doing regular television interviews with alumnae. The Mount's DUET personnel and university's public relations office were pleased with the first 13-week series and have already started on a second series, which also runs for 13 weeks.

Alumna Christine Shelton, DUETs production facilitator, says that she sees alumnae as potential DUET users. "The program also helps the casual viewer to get an idea of what university is all about," she says, "and it's nice for our student assistants in the studio to work on something a little different from the usual classroom sessions. In fact, we consider it a bit of a perk!"

The Alumnae Special can be seen on ASN in the metro area on Tuesdays and Thursday at 2:45 p.m. Outside metro, viewers should consult their local listings.



## Alumnae Support For Jubilee Scholarships Overwhelming

The establishment of Jubilee Scholarships last Fall brought an overwhelming response from Mount alumnae. Of the 23 scholarships, 19 were either donated by alumnae or were in honour of alumnae. That figure, representing approximately \$228,000, "speaks highly of the commitment of past graduates to the Mount and to the continuance of educational opportunities to students of high academic standing," said development director Lorraine Iohnson

The most recent scholarship commemorating the Mount's anniversary as a degree granting institution was the Sister Marie Agnes White Jubilee Scholarship established by Dr. Catherine Wallace.

Alumnae response to this scholarship fund to honour a devoted and well loved teacher has been tremendous, said Johnson. The goal for the scholarship is

\$12,000. To date, \$4,300.00 has already been contributed.

During her long association with the Mount, Sister served generations of Mount students as athletics director, dramatic coach, organist, student advisor and teacher of history, German and English. "To all these areas of service she brought an integrity and commitment which were truly outstanding," she said. In 1971, Sister Marie Agnes was

honoured by the university when she was granted Professor Emeritus status and became the recipient of the Mount's first honorary degree.

Johnson said that any who wish to honour Sister Marie Agnes should send their donation to the Development Office and make their cheque payable to Mount Saint Vincent University. "A named scholarship is a fitting

way to pay tribute to those we love. Each year in perpetuity a deserving student will receive a scholarship award of \$1,000 along with information on the donor and the person being honoured," she said.






