

Time off to vote

Employees eligible to vote in the federal election, Nov. 21, must be given time off to vote. Since the polls are open from 9 a.m.- 8 p.m., employees who normally leave at 5 p.m. may leave at 4 p.m., or employees may be given four consecutive hours off during the day, as per federal voting regulations. Supervisors and department heads should arrange staff hours to ensure that. whenever possible, all offices remain open until 5 p.m., while at the same time providing all eligible voters with the required four consecutive hours off to vote.
